RESOLUTION NO. 027 Series of 2020

(Re: Submission of documents by Shanghai Transport, Inc. relative to its application for the route Molino, Bacoor, Cavite to PITX under MC No. 2018-027)

WHEREAS, on 4 December 2019, the Qualification Committee issued its Resolution No. 306 S. 2019 wherein the committee resolved to DIRECT Shanghai Transport, Inc. to SUBMIT within fifteen (15) days from receipt of the aforementioned Resolution its **duly signed and notarized sworn undertaking that the remaining four (4) units will be made available within three (3) months**;

WHEREAS, Shanghai Transport, Inc. received the above-mentioned resolution on 11 December 2019;

WHEREAS, on 19 December 2019, Shanghai Transport Inc. submitted its duly signed and notarized Affidavit of Undertaking which states that **“xxx the remaining of four (4) units will be made available within three (3) months xxx”**;

WHEREAS, upon careful evaluation, the Qualification Committee finds that the above-mentioned document is compliant with the requirements set forth under Memorandum Circular No. 2019-013;

WHEREAS, Shanghai Transport, Inc. were given a rating of “PASSED/QUALIFIED” as it fully complied with the Qualification Requirements - Legal, Technical and Financial Capability provided under Memorandum Circular No. 2019-013;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to **AWARD** and **AUTHORIZE** the applied fifteen (15) UV units for the route Molino, Bacoor, Cavite to PITX under Memorandum Circular No. 2018-027 in favor of Shanghai Transport, Inc.
