**RESOLUTION NO. 031 Series of 2020**

(Re: Submission of documents by ACB Transport Services, Inc. relative to its application for the route: PITX - ALFONSO/MENDES)

**WHEREAS**, on 14 October 2019, the Qualification Committee issued its Resolution No. 237 S. 2019 wherein the committee resolved to DIRECT applicant ACB TRANSPORT SERVICES, INC. to SUBMIT within fifteen (15) days from receipt of the aforementioned Resolution the following documentary requirements to wit:

1. Undertaking that the units shall be compliant with the specifications and standards under OFG and DTI-PNS;
2. Undertaking that the applicant will immediately comply with the approved LPTRP/DOTr rationalization study;
3. Fleet Management System with organized vehicle dispatch procedures;
4. Evidence of formal arrangement with Automatic Fare Collection (AFC) service provider that will offer inter-operable AFC service that is fully compliant with fare media related technical specifications
5. Proof of financial capability of at least equal to the set-aside bank deposit, duly certified by the depository bank, which is equivalent to one hundred thousand pesos (Php 100,000.00) for PUB services per unit.

**WHEREAS**, ACB Transport Services, Inc. received the above-mentioned resolution on 8 November 2019;

**WHEREAS**, on 21 November 2019, ACB TRANSPORT SERVICES, INC. submitted the following documents for its compliance to the above-mentioned resolution, to wit:

1. Duly signed and notarized sworn undertaking dated 20 November 2019 that all units of ACB Transport Services, Inc. shall be compliant with the specifications and standards under the Omnibus Franchising Guidelines (OFG), Department of Trade and Industry - Philippine National Standards (DTI-PNS);
2. Duly signed and notarized sworn undertaking dated 20 November 2019 that ACB Transport Services, Inc. shall immediately comply with the approved Local Public Transport Route Planning-Department of Transportation (LPTRP/DOTr) rationalization study;
3. Duly signed evidence of formal arrangement with AF Payments, Inc. relative to Automatic Fare Collection (AFC) service duly signed by its Business Development - Johan Diaz and ACB Transport Services, Inc. President - Mary Grace Costes;
4. Fleet Management System with organized vehicle dispatch procedures;
5. Certificate of Bank Deposit and/or Placement numbered SMA-1161-19-096 dated 5 November 2019 from BDO Filinvest-Civic-Drive Branch duly signed by its Marketing Officer - Sheila Marie S. Nacionales and Branch Head - Francisca A. Dimatatac with available balance of Php 3,576,871.85 as of 4 November 2019;

**WHEREAS**, upon careful evaluation, the Qualification Committee finds that the above-mentioned submitted documents are fully compliant with the requirements set forth under Memorandum Circular No. 2019-013;

**WHEREAS**, ACB Transport Services, Inc. were given a rating of "PASSED/QUALIFIED" as it fully complied with the Qualification Requirements - Legal, Technical and Financial Capability provided under Memorandum Circular No. 2019-013;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to AWARD the PITX - ALFONSO/MENDES route under Resolution No. 218 S. 2019 in favor of ACB Transport Services, Inc.
