RESOLUTION NO. 096 Series of 2020

(Re: Application of Diamond Transport Service Cooperative for the Issuance of New CPC for the route: MOLINO, BACOR, CAVITE TO PITX under Memorandum Circular No. 2018-027)

WHEREAS, on 5 February 2020, Diamond Transport Service Cooperative filed its letter of intent and qualification documents to apply for the route MOLINO, BACOR, CAVITE TO PITX under Memorandum Circular No. 2018-027 with the use of fifteen (15) Class 3 UV units and that the selection proceedings was thereafter conducted on 11 March 2020;

WHEREAS, Diamond Transport Service Cooperative have complied with the Legal Qualifications set forth under Memorandum Circular No. 2019-013;

WHEREAS, the Committee found that Diamond Transport Service Cooperative has submitted a Certification dated 22 October 2019 from HINO CARMONA which certifies that Diamond Transport Service Cooperative has fifty (50) units purchase of Class III Type Jeepney (6-wheeler) with delivery schedule as follows:

The same certification stated that the units are all equipped with the following accessories:

- CCTV (Recording Only)
- Automatic Fare Collection System
- WIFI Ready
- Dash Cam and Backing Camera
- Global Positioning System (GPS)
- Fire Extinguisher (5 lbs.)
- Speed Limiter

WHEREAS, the delivery schedule stated above in the aforementioned certification should have been an undertaking made by Diamond Transport Service Cooperative under Section III-B-2 of Memorandum Circular No. 2019-013 which the applicant failed to submit/include in its qualification documents and that the certification from Hino Carmona is to certify/support the undertaking mentioned above;

WHEREAS, the Committee also found that the applicant has failed to include/submit in its qualification documents its undertaking that the units shall be compliant with the specifications and standards under OFG and DTI-PNS but have submitted a Certification dated 22 October 2019 from HINO CARMONA to certify that the PUJ units of HINO MOTORS PHILIPPINES CORPORATION are EURO 4 and Philippine National Standard (PNS2126-2017) Compliant Units;

WHEREAS, the Committee also found that the applicant has failed to include/submit in its qualification documents its undertaking that the Diamond Transport Service Cooperative will immediately comply with the approved DOTr/LPTRP rationalization study, Fleet Management System with organized vehicle dispatch procedures and manner of acquisition for the compliant PUV units identifying the funding source with detailed financing plan;

NOW THEREFORE, premises considered, this Committee resolves to DIRECT Diamond Transport Service Cooperative to SUBMIT within fifteen working (15) days from receipt of this resolution the following:

1. Diamond Transport Service Cooperative's undertaking that 25% of the number of required units within three (3) months, 50% within six (6) months, 100% within nine (9) months will be delivered as certified by the vehicle manufacturer/supplier;
2. Diamond Transport Service Cooperative's undertaking that the units shall be compliant with the specifications and standards under OFG and DTI-PNS;
3. Diamond Transport Service Cooperative's undertaking that they will comply with the approved DOTr/LPTRP route rationalization study;
4. Fleet Management System with organized vehicle dispatch procedure;
5. Manner of acquisition for the compliant PUV units identifying the funding source with detailed financing plan;


Failure to comply within the period specified herein shall cause the dismissal of the application.
