RESOLUTION NO. 99 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 13: BUENDIA - BGC under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the applications of **GREEN FROG ZE TRANSPORT CORPORATION, MEGA MANILA CONSORTIUM CORP.**, whose participating member-operator is listed in Annex "A", and **PAMANA TRANSPORT SERVICES** for the Issuance of Special Permit for the Route No. 13: BUENDIA - BGC with the use of twenty-two (22) authorized PUB units;

WHEREAS, after due evaluation, the Committee found that **GREEN FROG ZE TRANSPORT CORPORATION** is an area-based operator with twelve (12) units proposed to operate along the route;

WHEREAS, applicant has substantially complied with the legal and technical requirements provided under Memorandum Circular No. 2020-019;

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **GREEN FROG ZE TRANSPORT CORPORATION** for having substantially submitted/complied and to submit/comply immediately upon receipt hereof:
 - 1) Undertaking of Single-Monitoring System within two (2) weeks from Operation;
 - 2) Undertaking for Automated Fare Collection System (AFCS); Consortium with one (1) month from the date of operation;
 - 3) Current Registration (OR/CR) of Units; and
 - 4) Personal Passenger Insurance Policy.

2. Additionally, **GREEN FROG ZE TRANSPORT CORPORATION** is directed to complete within one (1) month the remaining ten (10) units of PUBs to ply Route No. 13: BUENDIA - BGC. It is directed

that **GREEN FROG ZE TRANSPORT CORPORATION** shall supply the units from other qualified city bus operators.
