RESOLUTION NO. 102 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 4: North EDSA – Fairview under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee are the Applications of **NAT TRANSPORT** whose participating member-operators are listed in Annex "A" and **MEGA MANILA CONSORTIUM CORP.** whose participating member-operators are listed in Annex "B" hereof, for the Issuance of Special Permit for the Route No. 4: North EDSA – Fairview with the use of One Hundred Seventy Three (173) authorized PUB units;

WHEREAS, perused of the documents submitted by both applicants on May 22, 2020, **NAT TRANSPORT** has One Hundred Seventy (170) units while **MEGA MANILA CONSORTIUM CORPORATION** has only One Hundred Sixty Six (166) units;

WHEREAS, after due evaluation based on the set guidelines and existing records of the Board, it is found that not all member-operators listed by both applicants are area-based operators,

WHEREAS, further evaluation revealed that **NAT TRANSPORT** has only fifty five (55) units from its qualified area-based participating members while **MEGA MANILA CONSORTIUM CORPORATION** has seventy four (74) units from its qualified area-based participating members;

WHEREAS, there is a big disparity between the unit requirement under Memorandum Circular No. 2020-019 and the total number of proposed units combined by both applicants **NAT TRANSPORT** and **MEGA MANILA CONSORTIUM CORPORATION**;

WHEREAS, higher demand of public transport is expected during the general community quarantine (GCQ), where the full seating capacity for PUBs is reduced to 50% seating capacity to guarantee that social distancing and other health protocols are observed;

NOW THEREFORE, pursuant to Memorandum Circular No. 2020-019, to avoid qualified area-based operator to be excluded from a particular route and in the exigency of service to provide sufficient number of public utility vehicles, with due regard to the interest of the commuting public during the GCQ period, this Committee resolves to recommend to the Board to;

1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORPORATION** for its initial seventy four (74) PUB units, and to immediately submit/comply from receipt hereof, the following;

- 1) Current Registration (OR/CR) of units and
- 2) Personal Passenger Insurance Policy of units applied for.

2. Additionally, **MEGA MANILA CONSORTIUM CORPORATION** shall complete the remaining ninety nine (99) units of PUBs to ply the Route No. 4: North EDSA – Fairview, within one (1) month from receipt hereof, which shall be sourced from other qualified existing area-based city bus operators, subject of its submission of consolidation agreement or common third party fleet-management agreement, as the case may be.


