RESOLUTION NO. 103 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the
Route No. 15: AYALA – BIÑAN under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee are the applications of **J&A CHUA MANAGEMENT GROUP**, whose participating member-operators are listed in Annex "A" hereof and **MEGA MANILA CONSORTIUM CORP.**, whose participating member-operators are listed in Annex "B" hereof, for the Issuance of Special Permit for the Route No. 15: AYALA – BIÑAN with the use of one hundred five (105) authorized PUB units;

WHEREAS, it appears that both applicants have deficiencies in the requirements, but were still considered for evaluation in the exigency of the need of public land transportation during GCQ, which shall be ranked based on their submission/compliance with the requirements;

WHEREAS, after due evaluation, the Committee found that **J&A CHUA MANAGEMENT GROUP** has applied for Ninety-Eight (98) units from its participating members, while **MEGA MANILA CONSORTIUM CORP.** has applied for One Hundred Forty (140) units;;

WHEREAS, close examination of the documents submitted by the applicants revealed that Metro Manila Bus Company, Inc. (one of the participating member-operators of **J&A CHUA MANAGEMENT GROUP**) with Twenty Five (25) units in the list, appears to be not an area-based operator, thus excluded in the proposed units, leaving a net count of Seventy Three (73) units; while one of the participating member-operators of **MEGA MANILA CONSORTIUM CORP.** particularly the South City Express, Inc. with Forty Four (44) units, have been found already included and considered in another route being applied by **MEGA MANILA CONSORTIUM CORP.**, thus, must be excluded in proposed list, leaving a net count of Ninety Six (96) units;

WHEREAS, further evaluation disclosed that although, both applicants' participating members are area-based operators, the member-operators of **J&A CHUA MANAGEMENT GROUP** appears to be single fleet-managed based on existing records of the Board, as compared to the participating member-operators of **MEGA MANILA CONSORTIUM CORP.**;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **J&A CHUA MANAGEMENT GROUP** initially for its Seventy Three (73) PUB units, and to immediately submit/comply from receipt hereof, the following;
 - 1) Current Registration (OR/CR) of units and
 - 2) Personal Passenger Insurance Policy of units applied for.
2. Additionally, **J&A CHUA MANAGEMENT GROUP** shall complete the remaining thirty two (32) units of PUBs to ply the Route No. 15 (AYALA – BIÑAN), within one (1) month from receipt hereof, which shall be sourced from other qualified existing area-based city bus operators, subject of its submission of consolidation agreement or common third party fleet-management agreement, as the case may be.




