RESOLUTION NO. 104 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 19: North EDSA – Bonifacio Global City under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee are the Applications of **NAT TRANSPORT**, whose participating member-operators are listed in Annex “A” and **MEGA MANILA CONSORTIUM CORPORATION**, whose participating member-operators are listed in Annex “B”, for the Issuance of Special Permit for the Route No. 19: North EDSA – Bonifacio Global City with the use of Eighty Six (86) authorized PUB units;

WHEREAS, it appears that both applicants have deficiencies in the requirements, but were still considered for evaluation in the exigency of the need of public land transportation services during GCQ, which shall be ranked based on the number of proposed number of units and their submission/compliance with the requirements;

WHEREAS, Route No. 19: North EDSA – Bonifacio Global City appears to be a new route, hence, no existing area-based operators;

WHEREAS, after due evaluation, the Committee found that **NAT TRANSPORT** has substantially submitted/complied the requirements, having submitted/applied eighty six (86) units from its participating member-operators; while Mega Manila Consortium Corporation has submitted/applied for only fifty one (51) units;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **NAT TRANSPORT** for Eighty Six (86) PUB units, plying Route No. 19: North EDSA - Bonifacio Global City, and to submit/comply immediately upon receipt hereof, the following:
 1. Current Registration (OR/CR) of units; and
 2. Personal Passenger Insurance Policy of units applied for.


