RESOLUTION NO. 107 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 30: PITX – CAVITE CITY under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee are the applications of **ONE CAVITE TRANSPORT OPERATORS, INC.** whose participating member-operators are listed in Annex "A" and **MEGA MANILA CONSORTIUM CORP.** whose participating member-operators are listed in Annex "B", for the Issuance of Special Permit for the Route No. 30: PITX – CAVITE CITY with the use of Eighty Nine (89) authorized PUB units;

WHEREAS, it appears that both applicants have deficiencies in the requirements, but were still considered for evaluation in the exigency of the need of public land transportation services during GCQ, which shall be ranked based on the number of proposed units and their submission/compliance with the requirements;

WHEREAS, after due evaluation, the Committee found that the group of **ONE CAVITE TRANSPORT OPERATORS, INC.** has applied for Ninety (90) units, while **MEGA MANILA CONSORTIUM CORP.** has applied for One Hundred Thirty Five (135) units;

WHEREAS, further evaluation revealed that all the units proposed by **MEGA MANILA CONSORTIUM CORP.** from its participating members are not area-based operators, while **ONE CAVITE TRANSPORT OPERATORS, INC.** has only Sixty Six (66) units from its participating area-based operators out of the Ninety (90) units it originally proposed;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **ONE CAVITE TRANSPORT OPERATORS, INC.** for the initial Sixty Six (66) PUBs units plying Route No. 30: (PITX – CAVITE CITY), and to immediately submit/comply upon receipt hereof, the following:
 1. Current Registration (OR/CR) of units; and
 2. Personal Passenger Insurance Policy of units applied for.
2. Additionally, **ONE CAVITE TRANSPORT OPERATORS, INC.** shall complete the remaining Twenty Three (23) PUB units to ply the Route No. 30: (PITX – CAVITE CITY), to be sourced from other existing qualified area-based city bus operators, with the directive to submit a consolidation agreement or common third party management agreement, within one (1) month from receipt hereof.

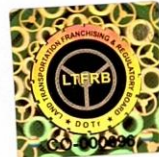
