**RESOLUTION NO. 108 Series of 2020**

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 12: KALENTONG - PASIG under Memorandum Circular No. 2020-019)

**WHEREAS**, before this Committee is the application of **MEGA MANILA CONSORTIUM CORP.**, whose participating members are listed in Annex "A", hereof, filed on 09 June 2020 for the Issuance of Special Permit for the Route No. 12: KALENTONG - PASIG with the use of sixty-five (65) authorized PUB units;

**WHEREAS**, during evaluation on 10 June 2020, the Committee found **MEGA MANILA CONSORTIUM CORP.** is the lone applicant for fifty-five (55) authorized PUB units, whose participating members are city bus operators;

**WHEREAS**, Route No. 12: KALENTONG - PASIG appears to be a new route, hence, no existing area-based operators;

**WHEREAS**, applicant has substantially complied with the legal and technical requirements provided under Memorandum Circular No. 2020-019.

**WHEREAS**, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORP.** for fifty-five (55) PUBs plying Route No. 12: KALENTONG – PASIG for having substantially submitted/complied the requirements, and to submit/comply immediately upon receipt hereof, the following:
  1. Current Registration (OR/CR) of units; and
  2. Personal Passenger Insurance Policy of units applied for.
2. Additionally, **MEGA MANILA CONSORTIUM CORP.** shall complete the remaining ten (10) units of PUBs to ply the Route No. 12: KALENTONG - PASIG within one (1) month from receipt hereof, which shall be sourced from other existing qualified city bus operators, subject of its submission of consolidation agreement or common third party fleet-management agreement, as the case may be.
