RESOLUTION NO. 109 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 10:
DOROTEO JOSE - CUBAO under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee are the applications of **MEGA MANILA CONSORTIUM CORPORATION**, whose participating members are listed in Annex "A" and **VICTORY LINER, INC.** (without participating members), for the Issuance of Special Permit for the Route No. 10: DOROTEO JOSE - CUBAO with the use of Seventy Three (73) authorized PUB units;

WHEREAS, Route No. 10: DOROTEO JOSE - CUBAO appears to be a new route, hence, no existing area-based operators;

WHEREAS, during evaluation and deliberation conducted on 10 June 2020, the Committee found that **MEGA MANILA CONSORTIUM CORP.** submitted/applied for Seventy Three (73) PUB units from its participating city bus operators, while **VICTORY LINER, INC.** has submitted/applied Twenty Two (22) PUB units;

WHEREAS, the coverage of Memorandum Circular No. 2020-019 as stated in item no. 1, are those operating in the National Capital Region and those that will be entering Metro Manila from nearby provinces;

WHEREAS, further examination of documents disclosed that the units submitted/applied by **VICTORY LINER, INC.** are all provincial buses, not operating in the National Capital Region or although may enter Metro Manila, but not from nearby provinces as provided under Annex "A" of the abovementioned Memorandum;

WHEREAS, applicant **MEGA MANILA CONSORTIUM CORP.** has substantially complied with the legal and technical requirements provided under Memorandum Circular No. 2020-019.

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle, with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORP.** for Seventy Three (73) PUBs plying Route No. 10: DOROTEO JOSE - CUBAO, and to submit/comply immediately upon receipt hereof, the following:

1. Current Registration (OR/CR) of units; and
2. Personal Passenger Insurance Policy of units applied for.


