**RESOLUTION NO. 111 Series of 2020**

(Re: RENEWAL OF ACCREDITATION OF MYTAXI.PH, INC. AS  
TRANSPORTATION NETWORK COMPANY)

**WHEREAS**, on 27 February 2020, after due evaluation and series of hearings, the Pre-Accreditation Committee for Transportation Network Company, created under Memorandum Circular No. 2015-015-A, issued Resolution No. 041A, series of 2020 wherein the committee resolved:

**"NOW THEREFORE**, in view of the foregoing, the Pre-Accreditation Committee has found the applicant to have complied all the requirements set forth under Memorandum Circular No. 2015-015-A, EXCEPT on its compliance with the financial capability to operate a TNC business where the PAC posed its reservation. Thus, the matter is left to the sound discretion of the Board for the approval or disapproval of MyTaxi.Ph, Inc.'s application for renewal of accreditation as Transport Network Company given the circumstances cited above."

**WHEREAS**, in the same resolution, the PAC has pointed out that notwithstanding the recorded trend of losses suffered by the applicant in the past years, its operation in 2019 generated a total net income of One Hundred Ninety Four Million Seven Hundred Thirty Nine Thousand Eight Hundred Thirty Six pesos (Php194,739,836), based on its 2019 Audited Financial Statement;

**WHEREAS**, aside from the positive result of its operation in 2019, which may appear to be a good start of recovering its losses from the previous years, the Board is also cognizant of the way the applicant complies and diligently settles its obligations with respect to the judgments rendered by the Board and other regulatory agencies;

**WHEREAS**, the Board is also aware that herein applicant was ordered to pay an administrative penalty by the Philippine Competition Commission on account of its failure to comply with their Commitment to Improve Customer Experience;


**NOW THEREFORE**, after due deliberation, taking into consideration the recommendation of the Pre-Accreditation Committee, the Board hereby resolves to GRANT the application for renewal of accreditation of herein TNC applicant, subject to the following conditions:

1. Continuing commitment to improve customer experience;
2. Commitment to pay any and all judgments and awards that may be rendered for any cause arising out of the operation of its TNC business.

Violation to any of the conditions mentioned above may warrant the revocation of the accreditation herein granted, in the spirit of protecting the welfare of the commuting public.

Accordingly, let a **Certificate of Conditional Accreditation** be issued to Applicant MyTaxi.Ph, Inc. as a Transportation Network Company.
