RESOLUTION NO. 116 Series of 2020

(Re: Issuance of SPECIAL PERMIT for the Route Nos. 110, 204, 208, and 311 under Annex C of Memorandum Circular No. 2020-023)

WHEREAS, before this Committee are the Applications for the Issuance of Special Permit of the following applicant-operators:

2. TOLFETANO CORPORATION	QMC Loop	20
3. PASIG MANDALUYONG QUIAPO OPERATORS DRIVERS ALLIANCE TRANSPORT SERVICE COOPERATIVE (PAMAQODA, TSC.)	Antipolo – Pasig via East Bank Road	15
4. PM JEEPNEY DRIVERS AND OPERATORS AND SERVICES, INC.	West Avenue – P. Noval via Del Monte	15

WHEREAS, after due evaluation, the Committee found that the aforementioned applicant-operators are the lone applicants for the subject routes and have submitted/complied with all the requirements;

WHEREAS, further review of the documents revealed that prior to the implementation of Community Quarantine in Metro Manila, PASIG MANDALUYONG QUIAPO OPERATORS DRIVERS ALLIANCE TRANSPORT SERVICE COOPERATIVE (PAMAQODA TSC) has applied for the issuance of CPC under Case No. NCR-PUJ-2019-03-00021 with the LTFRB-National Capital Region and has been operating the route Pasig (TP) – Quiapo (Echague) by virtue of a Provisional Authority using its Fifteen (15) PUV Modernized units; while TOLFELANO CORPORATION has also applied for the issuance of CPC under Case No. 2019-5838 with the LTFRB-Central Office and has been operating the route Brgy. Paliparan, Dasmarinas, Cavite to PITX using its Twenty (20) PUV Modernized units;

WHEREAS, pursuant to the existing policy of the Board, inter-regional routes are under the jurisdiction of the LTFRB-Central Office, while routes within Metro Manila are under the jurisdiction of the LTFRB-National Capital Region;

WHEREAS, the deployment of OFG compliant PUJ units in the National Capital Region (NCR) and nearby provinces entering NCR is needed to serve the commuting public during the period of GCQ or MGCQ;


NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:


1. **GRANT** the issuance of Special Permit to **TOLFETANO CORPORATION** for Twenty (20) OFG compliant PUJs, plying the Route No. 110: Quirino Highway – UP Town Center;
2. **GRANT** the issuance of Special Permit to **TOLFETANO CORPORATION** for Twenty (20) OFG compliant PUJs, plying the Route No. 204: QMC Loop;
3. **GRANT** the issuance of Special Permit to **PM JEEPNEY DRIVERS AND OPERATORS AND SERVICES, INC.** for Fifteen (15) OFG compliant PUJs, plying the Route No. 311: West Avenue – P. Noval via Del Monte;
4. **GRANT** the issuance of Special Permit to **PAMAQODA, TSC.** for Fifteen (15) OFG compliant PUJs, plying the Route No. 208: Antipolo – Pasig via East Bank Road; and
5. Further, the LTFRB-NCR shall endorse the records of **PAMAQODA, TSC.** under Case No. NCR-PUJ-2019-03-00021 to the Technical Division of LTFRB Central Office, which has jurisdiction over Route No. 208: Antipolo – Pasig via East Bank Road. Likewise, the LTFRB Central Office shall endorse the records of **TOLFETANO CORPORATION** under Case No. 2019-5838 to the Technical Section of LTFRB-NCR, which has jurisdiction over Route No. 110: Quirino Highway – UP Town Center.




