RESOLUTION NO. 65 A Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the
Route No. 14: Ayala - Alabang under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the application of **MEGA MANILA CONSORTIUM CORPORATION** whose participating member-operators are listed in Annex "A" for the Issuance of Special Permit for the Route No. 14: Ayala - Alabang with the use of One Hundred Seventy (170) authorized PUB units;

WHEREAS, during evaluation conducted on May 22, 2020, the Committee found that applicant **MEGA MANILA CONSORTIUM CORPORATION** is the lone applicant for the aforementioned route.

WHEREAS, **MEGA MANILA CONSORTIUM CORPORATION** applied for Four Hundred Thirty Six (436) authorized PUB units, whose participating members are area-based operators;

WHEREAS, applicant has substantially complied with the legal and technical requirements provided under Memorandum Circular No. 2020-019.


WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORPORATION** for **One Hundred Seventy (170)** PUBs, plying the Route No. 14: Ayala – Alabang and to submit/comply immediately upon receipt hereof, the following:
 1. Current Registration (OR/CR) of units; and
 2. Personal Passenger Insurance Policy of units applied.


