RESOLUTION NO. 66A Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 16: Ayala – FTI Complex under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the application of **NAT TRANSPORT**, whose participating member-operators are listed in Annex “A” hereof, and **MEGA MANILA CONSORTIUM CORP.**, whose participating member-operators are listed in Annex “B” for the Issuance of Special Permit for the Route No. 16: Ayala – FTI Complex with the use of One Hundred Three (103) authorized PUB units;

WHEREAS, after due evaluation, the Committee found that **NAT TRANSPORT** has applied for seventy eight (78) authorized PUB units, from its participating members which are area-based operators; while **MEGA MANILA CONSORTIUM CORP.** applied One Hundred Three (103) units from its participating members which are area-based operators;

WHEREAS, applicant **MEGA MANILA CONSORTIUM CORP.** has substantially complied with the legal and technical requirements provided under Memorandum Circular No. 2020-019.

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of One Hundred Three (103) GCQ Special Permit particularly to the units submitted and applied by **MEGA MANILA CONSORTIUM CORP.** and to submit/comply immediately upon receipt hereof, the following:

1. Current Registration (OR/CR) of units; and
2. Personal Passenger Insurance Policy of units applied.
