**WHEREAS**, applicant has substantially complied with the legal and technical requirements provided in Memorandum Circular No. 2020-019;


**WHEREAS**, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

1. Current Registration (OR/CR) for the PUBs applied for;
2. Personal Passenger Insurance Policy for the PUBs applied for.


