RESOLUTION NO. 68 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 18: PITX – NAIA Loop under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the application of **MEGA MANILA CONSORTIUM CORPORATION**, whose participating member-operator is listed in Annex "A" hereof, and **PITX-NAIA LOOP CONSORTIUM CORP.**, whose participating member-operator is listed in Annex "B" hereof, the Issuance of Special Permit for the Route No. 18: PITX – NAIA Loop with the use of Seventy Six (76) authorized PUB units;

WHEREAS, after due evaluation, pursuant to the criteria set in Memorandum Circular 2020-019, the Committee found that **MEGA MANILA CONSORTIUM CORPORATION** has Seventy Six (76) PUB units, sufficient to cover the unit requirement for Route No. 18: PITX – NAIA Loop from its participating members which are area-based operators, while **PITX-NAIA LOOP CONSORTIUM CORP.**, has Thirty Two (32) units from its participating member area-based operators.

WHEREAS, both parties have substantially submitted/complied all the requirements under Memorandum Circular No. 2020-019;

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:


1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORPORATION** for Seventy Six (76) PUBs, plying the Route No. 18: PITX – NAIA Loop and to submit/comply immediately upon receipt hereof, the following:
 1. Current Registration (OR/CR) of units; and
 2. Personal Passenger Insurance Policy of units applied.
