RESOLUTION NO. 69 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 17: Monumento–EDSA Taft under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the application of **NAT TRANSPORT**, whose participating member-operators are listed in Annex "A" hereof, for the Issuance of Special Permit for the Route No. 17: Monumento – EDSA Taft with the use of One Hundred Eighty Three (183) authorized PUB units;

WHEREAS, after due evaluation, the Committee found that **NAT TRANSPORT** is the lone applicant for the subject route with Fifty Seven (57) units being applied for, whose participating members are area-based operators, and has substantially submitted/complied all the requirements;

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special One Hundred Eighty Three (183) GCQ Special Permit particularly to the units submitted and applied by **NAT TRANSPORT**, and submit/comply immediately upon receipt hereof:
 1. Current Registration (OR/CR) of units; and
 2. Personal Passenger Insurance Policy of units applied.
2. Further, **NAT TRANSPORT** is directed to complete the One Hundred Eighty Three (183) units of PUBs to operate along Route No. 17: Monumento – EDSA Taft. It is directed that **NAT TRANSPORT** shall source and coordinate with the other existing area-based operators within the Route No. 17: Monumento–EDSA Taft or from other qualified city bus operators to supply the remaining one hundred twenty six (126) units within two (2) weeks receipt hereof.

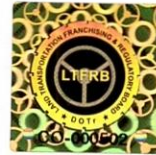
