RESOLUTION NO. 71 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 11: GILMORE - TAYTAY under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the application of **MEGA MANILA CONSORTIUM CORP.** for the Issuance of Special Permit for the **Route No.11: GILMORE - TAYTAY** with the use of one Seventy Eight (78) authorized PUB units;

WHEREAS, after due evaluation, the Committee found **MEGA MANILA CONSORTIUM CORP.**, whose participating member-operators are listed in Annex "A" hereof, is the lone applicant for Seventy Eighty (78) units;

WHEREAS, applicant has substantially complied with the legal and technical requirements provided in Memorandum Circular No. 2020-019;

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;


