**RESOLUTION NO. 73 Series of 2020**

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 8: CUBAO - MONTALBAN under Memorandum Circular No. 2020-019)

**WHEREAS**, before this Committee is the application of **MEGA MANILA CONSORTIUM CORP.**, whose participating member-operator is listed in Annex "A" hereof, for the Issuance of Special Permit for the Route No. 8: CUBAO - MONTALBAN with the use of seventy-eight (78) authorized PUB units;

**WHEREAS**, after due evaluation, the Committee found **MEGA MANILA CONSORTIUM CORP.** is the lone applicant for fifty-six (56) authorized PUB units, whose participating members are area-based operators;

**WHEREAS**, applicant has substantially complied with the legal and technical requirements provided under Memorandum Circular No. 2020-019.

**WHEREAS**, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to:


1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORP.** for seventy-eight (78) PUBs plying Route No. 8: CUBAO - MONTALBAN for having substantially submitted/complied the requirements, and to submit/comply immediately upon receipt hereof, the following:
  1. Proof of Garage
  2. Current Registration (OR/CR) of units; and
  3. Personal Passenger Insurance Policy of units applied for.
2. Additionally, **MEGA MANILA CONSORTIUM CORP.** is directed to complete the seventy-eight (78) PUBs to ply Route No. 8: CUBAO - MONTALBAN. It is directed that **MEGA MANILA CONSORTIUM CORP.** shall supply the units from other qualified city bus operators.
