**RESOLUTION NO. 74 Series of 2020**

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 28: PITX - DASMARIÑAS under Memorandum Circular No. 2020-019)

**WHEREAS**, before this Committee is the application of **MEGA MANILA CONSORTIUM CORP.** for the Issuance of Special Permit for the Route No. 28: PITX - DASMARIÑAS with the use of one hundred fifty-one (151) authorized PUB units;

**WHEREAS**, after due evaluation, the Committee found **MEGA MANILA CONSORTIUM CORP.** is a lone applicant for one hundred thirty four (134) units, whose participating members are area-based operators;

**WHEREAS**, applicant has substantially complied with the legal and technical requirements provided in Memorandum Circular No. 2020-019.

**WHEREAS**, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORP.** for one hundred fifty-one (151) PUBs plying Route No. 28: PITX - DASMARIÑAS for having substantially submitted/complied the requirements and to submit/comply immediately the following:
  1. Current Registration (OR/CR) of units; and
  2. Personal Passenger Insurance Policy of units applied for.
  
2. Additionally, **MEGA MANILA CONSORTIUM CORP.** shall submit an Undertaking to the Board that it will complete the one hundred fifty-one (151) PUBs to ply Route No. 28: PITX - DASMARIÑAS. It is advised that **MEGA MANILA CONSORTIUM CORP.** shall source and coordinate with the other existing area-based operators within Route 28 or from other qualified city bus operators to address the deficiency.
