RESOLUTION NO. 78 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 21: MONUMENTO - SJDM under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the application of **SJDM MARILAO BUS CONSORTIUM**, whose participating member-operators is listed in Annex "A" hereof, for the Issuance of Special Permit for the Route No. 21: MONUMENTO - SJDM with the use of one hundred five (105) authorized PUB units;

WHEREAS, after due evaluation, the Committee found **SJDM MARILAO BUS CONSORTIUM** is the lone applicant One Hundred Six (106) authorized PUB units, whose participating members are area-based operators;

WHEREAS, applicant has substantially complied with the legal and technical requirements provided under Memorandum Circular No. 2020-019.

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

GRANT the issuance of GCQ Special Permit to **SJDM MARILAO BUS CONSORTIUM** for one hundred five (105) PUBs plying No. 21: MONUMENTO - SJDM for having substantially submitted/complied the requirements and to submit/comply immediately upon receipt hereof, the following:

1. Revised Management Agreement to include Revenue Sharing details;
2. Current Registration (OR/CR) of units; and
3. Personal Passenger Insurance Policy of units applied.
