RESOLUTION NO. 80 Series of 2020

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 25: Bonifacio Global City – Alabang under Memorandum Circular No. 2020-019)

WHEREAS, before this Committee is the application of **MEGA MANILA CONSORTIUM CORPORATION**, whose participating member-operator is listed in Annex "A for the Issuance of Special Permit for the Route No. 25: Bonifacio Global City – Alabang with the use of One Hundred Fifty Six (156) authorized PUB units;

WHEREAS, after due evaluation conducted on May 22, 2020, the Committee found that **MEGA MANILA CONSORTIUM CORPORATION** is the lone applicant for the subject route with Thirty Nine (39) units being applied for, whose participating members are area-based operators, and has substantially submitted/complied all the requirements;

WHEREAS, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORPORATION** for One Hundred Fifty Six (156) PUBs, plying the Route No. 25: Bonifacio Global City – Alabang and to submit/comply immediately upon receipt hereof, the following:
 1. Current Registration (OR/CR) of units; and
 2. Personal Passenger Insurance Policy of units applied.
2. Further, **MEGA MANILA CONSORTIUM CORPORATION** is directed to complete within one (1) month the One Hundred Fifty Six (156) units of PUBs to operate along Route No. 25: Bonifacio Global City – Alabang. It is directed that **MEGA MANILA CONSORTIUM CORPORATION** shall supply the units from other qualified city bus operators.
