**RESOLUTION NO. 90 Series of 2020**

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 2: MONUMENTO – PITX under Memorandum Circular No. 2020-019)

**WHEREAS**, before this Committee are the applications of **MONUMENTO – PITX CONSORTIUM CORP.**, whose participating member-operator is listed in Annex “A” and **MEGA MANILA CONSORTIUM CORP.** whose participating member-operators are listed in Annex “B” hereof, for the Issuance of Special Permit for the Route No. 2: MONUMENTO – PITX with the use of ninety seven (97) authorized PUB units;

**WHEREAS**, after due evaluation pursuant to the criteria set in Memorandum Circular 2020-019, the Committee found that **MEGA MANILA CONSORTIUM CORP.**, whose participating member-operators are area-based operators has met the required number of 97 units to operate on the route, while **UBE EXPRESS**, as the participating member of **MONUMENTO – PITX CONSORTIUM CORP.**, is a not a grantee of CPC to operate PUB service within Metro Manila.

**WHEREAS**, applicant has substantially complied with the requirements provided under Memorandum Circular No. 2020-019;

**WHEREAS**, in the exigency of service to provide sufficient number of public utility vehicle with due regard to the interest of the commuting public during the GCQ period;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to **MEGA MANILA CONSORTIUM CORP.** for having substantially submitted/complied the requirements and to immediately submit/comply from receipt hereof, the following:

1. Current Registration (OR/CR) of Units; and
2. Personal Passenger Insurance Policy.


