MEMORANDUM CIRCULAR
NO. 2020-023- C

SUBJECT : ADDITIONAL ROUTES ALLOWED FOR THE OPERATION OF OFG-COMPLIANT PUJ VEHICLES DURING THE PERIOD OF GCQ IN METRO MANILA OR ENTERING METRO MANILA

WHEREAS, on 19 June 2020, the Board issued Memorandum Circular No. 2020-023 on the resumption of operations for OFG-compliant PUJ units starting 22 June 2020 during the period of General Community Quarantine (GCQ) in Metro Manila;

WHEREAS, pursuant to the guidelines of the Department of Transportation (DOTr) for a calibrated and gradual opening of public transportation in Metro Manila and those in nearby provinces, the Board, through the Franchise Planning and Monitoring Division (FPMD) has since then made the necessary monitoring on the daily operations of the initial routes allowed to operate;

WHEREAS, the FPMD recommended certain PUJ routes that need to be opened and those that have to be modified based on passenger demand;

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby allows the following **PUJ routes using OFG-Compliant vehicles** to operate within Metro Manila and those entering Metro Manila:

Preference shall be given to those existing operators that have already consolidated, with available OFG-compliant units and are originally operating on said route or adjacent thereto.

The provisions set forth under Memorandum Circular No. 2020-023 dated 19 June 2020 shall be applicable herein. Accordingly, the following procedure shall be observed:

1. For routes under Items 1 to 3, they shall be considered as part of Annex “A” of MC No. 2020-023. Those operator with pending Petitions for Consolidation with OFG-Compliant units on said routes shall be issued corresponding Provisional Authority to operate.
2. For routes under Items 7 and 8, said routes shall form part of Annex “B” of MC No. 2020-023. Those operators with pending Petitions for Consolidation with OFG-Compliant units shall be issued the corresponding Special Permits to operate on the modified route.

3. For routes under Item 4-6, it shall be treated as part of Annex "C" of MC No. 2020-023 and shall undergo the Selection Process under said MC. Interested operators shall submit the required documents within three (3) working days from date hereof via email at puvmp.pmo.ncr@gmail.com.

All issuances inconsistent herewith are hereby superseded and amended accordingly.

This Memorandum Circular shall take effect immediately following its publication in a at least one (1) newspaper of general circulation. Let three (3) copies hereof be filed with the UP Law Center – Office of National Administrative Registrar (ONAR).

- For routes under items 7 and 8, said routes shall form part of Annex "B" of MC No. 2020-023. Those operators with pending Petitions for Consolidation with OFG-Compliant units shall be issued the corresponding Special Permits to operate on the modified route.
- For routes under item 4-6, it shall be treated as part of Annex "C" of MC No. 2020-023 and shall undergo the Selection Process under said MC. Interested operators shall submit the required documents within three (3) working days from date hereof via email at puvmp.pmo.ncr@gmail.com.

All issuances inconsistent herewith are hereby superseded and amended accordingly.
