RESOLUTION NO. 137 Series of 2020

(Re: Application of CITY STAR CRUISE, INC. for the opening of additional Taxi Franchise for Metro Manila including MUCEP Area under Memorandum Circular Nos. 2018-026 and 2019-051)

WHEREAS, on 19 December 2018, the Board issued Memorandum Circular No. 2018-026 also known as the "Opening of Additional Taxi Franchise for Metro Manila including MUCEP Area" to hereby OPEN additional air-conditioned taxi franchise for five thousand (5,000) units for Metro Manila including the MUCEP area;

WHEREAS, on 23 September 2019, the Board issued Memorandum Circular No. 2019-051 also known as the "Amendment to Memorandum Circular No. 2018-026 (Reduction in the Minimum Number of Units per Application)" to REDUCE the minimum number of units per application to twenty-five (25) units and that the maximum remains at one thousand (1,000) units;

WHEREAS, on 12 December 2019, CITY STAR CRUISE, INC. filed its application for the opening of additional taxi franchise for Metro Manila including MUCEP area under Memorandum Circular No. 2018-026 with the use of twenty-five (25) taxi units and that the selection proceedings were thereafter conducted on 4 March 2020;

WHEREAS, the Committee found that CITY STAR CRUISE, INC. were given a rating of "**PASSED/QUALIFIED**" as they have fully complied with the Qualification Requirements - Legal, Technical and Financial Capability requirements under Memorandum Circular No. 2018-026;

NOW THEREFORE, premises considered, this Committee resolves to recommend to the Board to **GRANT** the application of CITY STAR CRUISE, INC. for the opening of additional taxi franchise for Metro Manila including MUCEP area with the use of twenty-five (25) taxi units pursuant to Memorandum Circular Nos. 2018-026 and 2019-051.
