**BOARD RESOLUTION NO. 145 Series of 2020**  
**(Re: EXTENSION OF PERIOD FOR CONFIRMATION OF UNITS)**

**WHEREAS**, in December 2019, the World Health Organization was alerted of several respiratory cases which were later on attributed to what is now known as the "Corona Virus Disease (Covid-19)";

**WHEREAS**, President Rodrigo Roa Duterte signed Proclamation No. 922 entitled "*Declaring a State of Public Health Emergency Throughout the Philippines*" on 08 March 2020;

**WHEREAS**. On 29 April 2020, the Board issued Board Resolution No. 62 which provided the guidelines extending the period of filing and waiver of penalties for select transactions;

**WHEREAS**, On 9 May 2020, Board Resolution No. 100 was issued by the Board amending the above mentioned Board Resolution by extending the periods of the following:

1. Filing Application for Extension of Validity;
2. Validity of Provisional Authorities and Special Permits, and
3. Compliance to the Orders, Resolutions and Decision of the Board;

**WHEREAS**, On June 24, 2020, the Land Transportation Office has issued Memorandum Circular No. 2020-2193, Re: **EXTENSION OF VALIDITY OF RENEWAL REGISTRATION FOR VEHICLES WITH PLATE NUMBERS ENDING IN 6,7,8,9 AND 0 FOR CALENDAR YEAR 2020**

**WHEREAS**, in order to conform with the issuance mentioned in the immediate preceding paragraph, and taking into account the present situation brought about by the global pandemic and the authority and interest of our stakeholders and the general public, the Board deems it necessary to extend the confirmation of units;


**NOW THEREFORE**, for and consideration of the foregoing, the Board hereby **AMENDS** Board Resolution No. 100, Series of 2020 by incorporating extension of period for confirmation of units, which shall be as follows:

- A. All PUVs with Plate Numbers ending in **7** will be **allowed to confirm** their units until **31 August 2020** with **waiver penalties**;
- B. All PUVs with Plate Numbers ending in **8** will be **allowed to confirm** their units until **30 September 2020** with **waiver penalties**;
- C. All PUVs with Plate Numbers ending in **9** will be **allowed to confirm** their units until **31 October 2020** with **waiver penalties**;

- D. All PUVs with Plate Numbers ending in **0** will be **allowed to confirm** their units until **30 November 2020** with **waiver penalties**

In this regard, the corresponding insurance policies under the Personal Passenger Accident Insurance Program (PPAIP) of PUV units covered under this item shall be automatically extended until the period corresponding to the ending of Plate Numbers above mentioned without additional fees on the part of the operators. Within the period given, operators are required to secure renewal or updated insurance policies as part of confirmation of their units.
