**RESOLUTION NO. 163 Series of 2020**

(Re: General Community Quarantine (GCQ) SPECIAL PERMIT for the Route No. 33: Santa Rosa Integrated Terminal to Ayala Avenue via SLEX under Memorandum Circular No. 2020-038)

**WHEREAS**, before this Committee is the application of **MEGA MANILA CONSORTIUM CORPORATION** for the Issuance of Special Permit for the Route No. 33: Santa Rosa Integrated Terminal to Ayala Avenue via SLEX with the use of seventy two (72) authorized PUB units;

**WHEREAS**, after due evaluation, the Committee found that **MEGA MANILA CONSORTIUM CORPORATION** is the only applicant for the Route No. 33, with a total number of sixty (60) proposed PUB units from its participating qualified area-based operators, the details of which are listed under Annex "A";

**WHEREAS**, **MEGA MANILA CONSORTIUM CORPORATION** has substantially complied with the General, Legal and Technical Requirements, as required under Memorandum Circular No. 2020-038, in relation to Memorandum Circular No. 2020-019;

**WHEREAS**, there exist an exigency of service to provide sufficient number of public utility vehicle, taking into account the interest of the commuting public during the GCQ period;

**NOW THEREFORE**, premises considered, this Committee resolves to **RECOMMEND** to the Board to:

1. **GRANT** the issuance of GCQ Special Permit to the lone applicant, **MEGA MANILA CONSORTIUM CORPORATION** to ply Route No. 33: Santa Rosa Integrated Terminal to Ayala Avenue via SLEX, for having substantially submitted/complied all the requirements.

Additionally, **MEGA MANILA CONSORTIUM CORPORATION** shall complete the total authorized number of seventy two (72) PUB units and to submit a list to the Board for the twelve (12) PUB units, within thirty (30) days from receipt hereof, which may be sourced from its participating area-based members or other qualified area based operators.


