**MEMORANDUM CIRCULAR**  
**NUMBER 2020- 094**

**Subject: SEVEN (7) YEAR VALIDITY PERIOD FOR CPCs GRANTED  
UNDER THE PUVMP PER DO 2017-011**

---

**WHEREAS**, the Secretary of the Department of Transportation issued Department Order No. 2017-011, Re: OMNIBUS GUIDELINES ON THE PLANNING AND IDENTIFICATION OF PUBLIC ROAD TRANSPORTATION SERVICES AND FRANCHISE ISSUANCE, which adopted rules and procedures for the issuance of franchises for public transport routes and services;

**WHEREAS**, On March 13, 2018, this Board issued Memorandum Circular No. 2018-006, Re: GUIDELINES FOR THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM'S INITIAL IMPLEMENTATION PURSUANT TO DEPARTMENT ORDER NO. 2017-11, OTHERWISE KNOWN AS THE OMNIBUS FRANCHISING GUIDELINES

**WHEREAS**, Memorandum Circular No. 2018-008, Re: CONSOLIDATION OF FRANCHISE HOLDERS IN COMPLIANCE WITH DEPARTMENT ORDER NO. 2017-011, OTHERWISE KNOWN AS OMNIBUS FRANCHISING GUIDELINES was issued by this Board on March 16, 2018.

**WHEREAS**, modernization of units compliant with the specifications and standards for modernized public land transportation system, and the industry consolidation under a fleet management system are the key components of the above-mentioned issuances;

**WHEREAS**, there are stakeholders who complied or in the process of complying with the modernization program of the DOTr and this Board, and as we commend them for their efforts despite this trying period, it is but reasonable to grant them incentive for their faithful compliance to the government's programs and directives;

**NOW THEREFORE**, this Board hereby **GRANTS a period of SEVEN (7) YEARS** to all Certificates of Public Convenience (CPC) issued under the PUV Modernization Program for all modes of public land transport service with brand-new, OFG-compliant units. All CPCs previously issued on all modes of transport service under the PUVMP shall be covered and modified accordingly.

All other issuances inconsistent herewith are deemed modified or superseded accordingly.

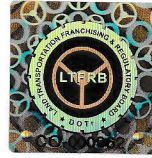
