MEMORANDUM CIRCULAR
NO. 2020-060

**SUBJECT : MODIFICATION OF SELECT PUJ ROUTES PER
MC NO. 2020-040**

WHEREAS, pursuant to the guidelines of the Department of Transportation (DOTr) for a calibrated and gradual opening of public transportation in Metro Manila and those in nearby provinces, the Board has since then made the necessary monitoring on the daily operations of the initial routes allowed to operate;

WHEREAS, under Item II.b. of MC 2020-026, the Board may issue additional routes to resume operations based on passenger demand;

WHEREAS, based on the monitoring and coordination with local government units in Metro Manila, there is a continuous need to open additional routes for traditional PUJs to serve passenger demand;

WHEREAS, in anticipation of the resumption of operations for public transportation in Metro Manila, the Board issued Memorandum Circular No. 2020-040 on 21 August 2020 allowing the opening and operations of Traditional PUJs during the period of GCQ Metro Manila;

WHEREAS, on 07 September 2020 and 28 September 2020, the Board received letters from the Chancellor of the University of the Philippines regarding existing PUJ routes entering the campus, and which, upon review and consideration, the Board finds the necessity to amend to conform with the existing public need within the area;

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby **AMENDS** the following PUJ route as follows:

The provisions set forth under Memorandum Circular No. 2020-019 shall continue to be applicable herein.

Operators on the aforementioned routes are directed to strictly comply with the amended route structure. Failure thereof shall be dealt with in accordance with applicable law, rules and regulations of the Board.

All other issuances inconsistent herewith are deemed modified or superseded accordingly.

This Memorandum Circular shall take effect immediately following its publication in at least one (1) newspaper of general circulation. Let three (3) copies hereof be filed with the UPLaw Center – Office of National Administrative Registrar (ONAR).
