**RESOLUTION NO. 199 Series of 2020**  
**(Re: MOTION FOR RECONSIDERATION OF KNIGHTS TRANSPORT SERVICE CORP.)**

**WHEREAS**, On August 4, 2020, Resolution No. 139 Series of 2020 was issued by the Pre-Qualification Committee which was affirmed by the Board denying the Application for Issuance of Certificate of Public Convenience to Operate Premium Taxi Service (Silver) under MC 2019-032 of Knights Transport Service Corp. for failure to submit the required qualification documents enumerated thereat

**WHEREAS**, Motion for Reconsideration was filed by Knights Transport Service Corp attaching therein the documents it failed to submit as part of the qualification documents that was used by the committee as basis for its recommendation, which was denied by the Committee and affirmed by the Board per now subject assailed Resolution

**WHEREAS**, Memorandum Circular No 2020-048, Re: AMENDMENT TO MC 2019-032 dated September 22, 2020 was issued by the Board, which AMENDS and MODIFIES Memorandum Circular No. 2019-032, by eliminating the pre-qualification process part thereof, particularly items 5.3 - SUBMISSION OF QUALIFICATION DOCUMENTS, 5.4-THE PRE-QUALIFICATION COMMITTEE AND ITS PROCESS, and 5.5 - EVALUATION OF QUALIFICATION DOCUMENTS. Accordingly, Applicants may now DIRECTLY file their Applications for Certificate of Public Convenience to Operate Premium Taxi Service with complete requirements provided under MC 2019-0032 to the Technical Division of this Board

**WHEREAS**, after review and evaluation of the subject Motion, the Board agreed that Knights Transport Service Corp. should benefit from the issuance of the above mentioned circular.

**NOW THEREFORE**, the Pre Qualification Committee resolves to as it is hereby resolved to GRANT the Motion for Reconsideration of Knights Transport Service Corp.

Accordingly, let the records of this case be transmitted to the Technical Division for further evaluation, and Knights Transport Service Corp. is directed to file corresponding Application for Issuance of Certificate of Public Convenience which shall be processed pursuant to MC 2020-048.
