MEMORANDUM CIRCULAR
NO. 2020-070

**SUBJECT : MODIFICATION OF SELECT PUJ ROUTE PER
MC NO. 2020-037**

WHEREAS, pursuant to the guidelines of the Department of Transportation (DOTr) for a calibrated and gradual opening of public transportation in Metro Manila and those in nearby provinces, the Board has since then made the necessary monitoring on the daily operations of the initial routes allowed to operate;

WHEREAS, under Item II.b. of MC 2020-026, the Board may issue additional routes to resume operations based on passenger demand;

WHEREAS, based on the monitoring and coordination with local government units in Metro Manila, there is a continuous need to open additional routes for traditional PUJs to serve passenger demand;

WHEREAS, in anticipation of the resumption of operations for public transportation in Metro Manila, the Board issued Memorandum Circular No. 2020-037 on 15 August 2020 allowing the opening and operations of Traditional PUJs during the period of GCQ Metro Manila;

WHEREAS, upon coordination with the Metropolitan Manila Development Authority (MMDA), in view of the closure of U-turn slots along EDSA, the Board finds the necessity to amend to conform with the existing public need within the area;

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby **AMENDS** the following PUJ route effective 07 November 2020 as follows:
