**RESOLUTION NO. 237 Series of 2020**

(Re: Accreditation of Journeytech Inc.  
as a GPS Device Provider)

**WHEREAS**, on 13 August 2020, the Pre-Accreditation Committee for GPS Device Providers created under Memorandum Circular No. 2015-013 issued a Resolution numbered 151 series of 2020 wherein the Committee resolved:

**“NOW THEREFORE**, premises considered, finding the documents submitted by Journeytech Inc. on 9 March 2020 to be incomplete due to its failure to submit/provide the above-mentioned documentary requirements set forth under Memorandum Circular Nos. 2015-013 and 2016-016, this Committee resolves to **DIRECT** the herein applicant to **SUBMIT** to the Pre-Accreditation Committee of the same within the fifteen (15) working days from receipt of this resolution.”


**WHEREAS**, the documentary requirements which the applicant Journeytech Inc. needed to submit are the following:

1. Valid Mayor's or Business Permit;
2. Certificate of Registration duly issued by the Bureau of Internal Revenue;
3. List of all clients (with contact person, address, and telephone/mobile number) in the transportation industry;
4. Updated NBI Clearance of Technicians;
5. Warranty of the GPS Device, which shall not be less than one (1) year from installation;
6. Undertaking of applicant to comply with the provisions of PNS ISO/IEC 17025, within 1 year from accreditation;
7. Company Policy and procedure for resolution of complaints from the operators;

**WHEREAS**, on 18 November 2020, applicant Journeytech Inc. submitted its compliance to the above-mentioned resolution wherein an evaluation was thereafter conducted by the Committee and a recommendation was made on 4 December 2020;

**NOW THEREFORE**, premises considered, finding the application of Journeytech Inc. complete and compliant with Memorandum Circular Nos. 2015-013 and 2016-016, this Committee hereby recommends to the Board to **GRANT** the application of Journeytech Inc. for a Certificate of Accreditation as a GPS Device Provider.
