MEMORANDUM CIRCULAR
NO. 2020- 083

SUBJECT : ADDITIONAL ROUTES ALLOWED FOR THE OPERATION OF OFG-COMPLIANT VEHICLES (PUJ and UVE) DURING THE PERIOD OF MGCQ/GCQ IN METRO MANILA OR ENTERING METRO MANILA

WHEREAS, on 19 June 2020, the Board issued Memorandum Circular No. 2020-023 on the resumption of operations for OFG-compliant Public Utility Jeepneys (PUJ) units starting 22 June 2020 during the period of General Community Quarantine (GCQ) in Metro Manila;

WHEREAS, on 26 June 2020, the Board issued Memorandum Circular No. 2020-025 on the resumption of operations for UV Express (UVE) units starting 03 July 2020 during the period of General Community Quarantine (GCQ) in Metro Manila;

WHEREAS, pursuant to the guidelines of the Department of Transportation (DOTr) for a calibrated and gradual opening of public transportation in Metro Manila and those in nearby provinces, the Board, through the Franchise Planning and Monitoring Division (FPMD) has since then made the necessary monitoring on the daily operations of the initial routes allowed to operate;

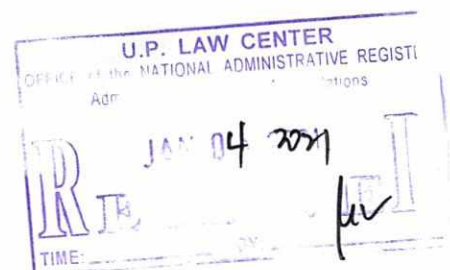
WHEREAS, the FPMD, Technical Division and PUVMP PMO recommended the herein modern PUJ and UVE routes that need to be opened and those that have to be modified based on passenger demand;

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby allows the following **PUJ and UVE routes using OFG-Compliant vehicles** to operate within Metro Manila and those entering Metro Manila starting **DECEMBER 21, 2020**:

All issuances inconsistent herewith are hereby superseded and amended accordingly.


