BOARD RESOLUTION NO. 021 Series of 2021
(Re: MC 2020-076, RE: MANDATORY TREE PLANTING)

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) was created by virtue Executive Order No. 202 dated June 19, 1987, as administrative agency with quasi-judicial powers, and is the existing franchising and regulatory body for land transportation today;

WHEREAS, On November 20, 2020, this Board issued Memorandum circular No. 2020-076, Re: MANDATORY TREE PLANTING, which directed for initial implementation, applicants for new CPC with ten units to plant one (1) tree for every unit applied for. After the initial implementation, all applicants with at least ten (10) units shall likewise be required to do the same;

WHEREAS, under the said MC, applicants/operators concerned shall coordinate with the local government unit or Department of Environment and Natural Resources Office on the area allowed for tree planting activity, and shall be required to secure proof of compliance therewith from the LGU or DENR;

WHEREAS, during consultation meeting with the officials of DENR and the Board's Regional Offices regarding the initial tree planting implementation, it was recommended thereat that in order not to impede and disrupt the process of applications of concerned operators, they shall now be allowed to file an undertaking to comply with the tree planting activity requirement within six (6) month period, in lieu of proof of compliance with NC 2020-076 from LGU and DENR ;

WHEREAS, the said recommendation was deliberated upon by the Board, and it was agree that the same be adopted for the uninterrupted process of all applications;

NOW THEREFORE, for and in consideration of the foregoing, the Board hereby allows that in lieu of proof of compliance with MC 2020-076 from LGUs and DENR prior to the filing of Applications involving ten (10) units or more, applicants concerned shall submit an Undertaking to comply with the tree planting activity requirement within a six (6) month period



from date of filing of application, and subsequently submit the required Certificate of compliance within said period.

Accordingly, Regional Directors of Regional Franchising Regulatory Offices are directed to monitor compliance with concerned applicant's undertaking, and shall submit monthly report therewith to the Office of the Executive Director
