**BOARD RESOLUTION NO. 029**  
**Series of 2021**

**WHEREAS**, due to the continued surge of Covid-19 cases, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases issued Resolution No. 106-A, series of 2021 endorsing to the President the placing of National Capital Region, provinces of Bulacan, Cavite, Laguna and Rizal under Enhanced Community Quarantine immediately upon approval until 4 April 2021;

**WHEREAS**, on 27 March 2021, Presidential Spokesperson Harry Roque announced that President Rodrigo Duterte has approved the Resolution of the IATF placing Metro Manila and the nearby provinces of Bulacan, Cavite, Laguna and Rizal under the strictest quarantine level from March 29 to April 4, 2021;

**WHEREAS**, in a Memorandum dated 28 March 2021 re: Implementation of Free Rides for APORS in all City Bus and Modern Jeepney Routes in Areas Placed under Enhanced Community Quarantine, the Department of Transportation has recommended that the operators and drivers of the city bus and modern public utility jeepney routes in the areas placed under ECQ be enrolled in the PUV Service Contracting Program and provide free rides during the ECQ period;


**WHEREAS**, the Board issued Board Resolution No. 028, series of 2021 which included Modern PUJs offering free rides during the period of ECQ plus in accordance with IATF Resolution No. 106-A, and likewise adopted the procedure and payment scheme under MC No. 2021-008;

**WHEREAS**, on 03 April 2021, President Rodrigo Roa Duterte approved the recommendation of the IATF to extend the Enhanced Community Quarantine in NCR plus until 11 April 2021;

**WHEREAS**, on 03 April 2021, the Board issued Memorandum Circular No. 2021 - 022, increasing the Kilometer Fee Rate for free rides of PUBs from Forty-Six pesos & 80/100 (Php46.80) to Eighty-Two pesos & 50/100 (Php82.50), and Fifty-Two pesos & 50/100 (Php52.50) for Modern PUJs;

**NOW THEREFORE**, for and in consideration of the foregoing, the Board resolves as it hereby resolved to increase the Kilometer Fee Rate of free rides for City Buses and Modern PUJs pursuant to MC No. 2021 – 022 and Board Resolution 028 s. 2021 particularly those operating in areas placed under the Enhanced Community Quarantine, which shall now be from Forty Six pesos & 80/100 (Php46.80) to Eighty Two pesos & 50/100 (Php82.50) for PUBs, and Fifty Two pesos & 50/100 (Php52.50) for Modern PUJs.


