BOARD RESOLUTION NO. 042
Series of 2021

WHEREAS, on 11 September 2020, President Rodrigo Roa Duterte signed into law the Republic Act No. 11494, otherwise known as the Bayanihan to Recover as One Act, which mandates the implementation of a comprehensive program to address the multifarious need of the Filipino people to recover from the COVID-19 pandemic which included the adversely affected transport sector;

WHEREAS, as part of the COVID-19 response and recovery interventions under Section 4, paragraph (g), item 1 of the same Act, the DOTr commits to implement the provision of support to road-based public transport stakeholders through the direct cash subsidies which shall provide relief to the critically-impacted stakeholders to cushion the negative effect of COVID-19 pandemic in their daily operations;

WHEREAS, subsequently, Republic Act No. 11519 was enacted, extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act, which includes, among others the automatic appropriations of new programs, projects, and activities pursuant to Section 4 thereof, which shall be available for release, obligation and disbursement until June 30, 2021

WHEREAS, the DOTr, in the exercise of its mandate, to call upon any agency to participate and assist in the preparation and implementation of its program, designate the LTFRB as the implementing agency in the implementation, monitoring and evaluation of the Service Contracting Program;

WHEREAS, incident to the implementation of the program is the preparation of documentary requirements for the purpose of legal documentation and mandatory reporting with the concerned agencies;

NOW THEREFORE, for and in consideration of the foregoing and by virtue of a Special Order (SO) No. 2021-051 dated 25 March 2021 designating Mr. Joel J. Bolano as Officer-in-Charge of the Office of the Executive Director, the Board resolves as it is hereby resolved to **AUTHORIZE Mr. JOEL J. BOLANO to SIGN**, on behalf of the Land Transportation Franchising and Regulatory Board documents relative to **Service Contracts with the Beneficiaries of the Program** effective from the date of the Special Order and until the same is actually or impliedly recalled.


