LAND TRANSPORTATION FRANCHISING & REGULATORY BOARD

**BOARD RESOLUTION NO. 099
SERIES OF 2021**

WHEREAS, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Board issued Board Resolution No. 62 dated 29 April 2020 and Board Resolution No. 100 dated 09 May 2020 which provided the guidelines extending the period of filing and waiver of penalties for select transactions;

WHEREAS, given the continued health situation in the country, different parts of the country are still placed under Enhanced Community Quarantine (ECQ) or Modified ECQ (MECQ);

WHEREAS, most of the Regional Franchising and Regulatory Offices (RFROs) as well as the Central Office, are still operating under limited personnel which continues to affect LTFRB's usual processes;

WHEREAS, the Board, in the exercise of its power and functions to "promulgate rules and regulations governing proceedings before the Board and the Regional Franchising and Regulatory Offices; as provided under Section 5(i) of Executive Order No. 202", deems it appropriate to amend its rules and regulations;

NOW THEREFORE, for and in consideration of the existing health emergency and ECQ/MECQ classifications across the country, the Board hereby resolves as it hereby resolved to promulgate the following guidelines for the **Central Office and Regional Franchising and Regulatory Offices (RFROs) which are under ECQ or MECQ during the month of August 2021:**

a. On Confirmation of Units:

1. All PUVs with Plate Number ending in 8 will be allowed to confirm their units until 30 September 2021 with **waiver of penalties.**

In this regard, the corresponding insurance policies under the Personal Passenger Accident Insurance Program (PPAIP) of PUV units covered under this item shall be automatically extended until 30 September 2021 without additional fees on the part of the operators. Within the period given, operators are required to secure renewal or updated insurance policies as part of the confirmation of their units.

b. On Filing of Extensions of Validity for CPCs

1. Application for Extension of Validity (EOV) for Certificate of Public Convenience (CPC) with expiry dates from 1 August 2021 to 31 August 2021 can be filed until 30 September 2021 with waiver of penalties.

For CPC with expiry from 01 August 2021 to 31 August 2021, operators can file their application for EOV until 30 September 2021 with waiver of penalties.

c. On Issuance of Provisional Authorities and Special Permits

1. All Provisional Authorities and Special Permits (SP) issued with expiry dates covering the period of 01 August 2021 to 31 August 2021, shall be extended until 30 September 2021 with waiver of fees.

Within the given period, all TNVS operators are required to process their applications accordingly, failure of which shall cause the dismissal of their applications.

d. On Compliance Orders, Resolutions, and Decisions directing operators to comply within a given period


2. Compliance Orders, Resolutions, and Decisions which direct operators to comply within a certain period and which period falls between 01 August 2021 to 31 August 2021 shall be extended until 30 September 2021 with waiver of penalties, if any.


