## BOARD RESOLUTION NO. 093 Series of 2021

WHEREAS, pursuant to Section 5(a) and (b) of Executive Order No. 202, dated June 19, 1987, the Land Transportation Franchising and Regulatory Board (LTFRB) shall have the power "to prescribe and regulate routes of service, economically viable capacities and zones or areas of operation of public land transportation services provided by motorized vehicles, xxx", and to issue, amend, revise, suspend or cancel Certificates of Public Convenience or permits authorizing the operation of public land transportation services provided by motorized vehicles, and to prescribe the appropriate terms and conditions therefore;

WHEREAS, Rural Transit Mindanao, Inc. (RTMI) is a grantee of Certificate of Public Convenience to operate Public Utility Bus on the route: Dipolog City – Pagadian City and vice versa with the use of twenty (20) units, which CPC is valid until 25 August 2021;

WHEREAS, in a letter dated 8June 2021, RTMI, thru its Branch Manager, Mr. German F. Avenido seeks the approval from the Honorable Board to permit them to file a Petition for the Inclusion of the "via route" to their CPC with Case No. 2016-09-00286 under the route: Dipolog City – Pagadian City and vice versa;

WHEREAS, in support of their request, they submitted the letter of support from the Mayor of Pagadian City, Provincial Governor of Zamboanga Del Sur, Mayor of Molave, Mayor of Siayan and Mayor of Dipolog City favorably endorsing the approval of their intention to modify their existing route from Pagadian City - Dipolog City to Pagadian City - Dipolog City via Molave, Zamboanga del Sur, Siayan, Zamboanga del Norte and Sindangan, Zamboanga del Norte;

WHEREAS, the common reasons cited by the concerned LGUs in expressing their support and endorsement are not only will shorten the travel time from Pagadian to Dipolog City but also promote accessibility of Municipalities in Zamboanga del Sur and Zamboanga del Norte, which will redound to the benefit of Local Government Units (LGUs) concerned and the riding public, in general;

NOW THEREFORE, for and in consideration of the foregoing, and in the interest of promoting public interest, the Board RESOLVES as it hereby resolved to Allow Rural Transit Mindanao, Inc. to file a Petition for Modification of Route from Pagadian City - Dipolog City to Pagadian City - Dipolog City via Molave, Zamboanga del Sur, Siayan, Zamboanga del Norte and Sindangan, Zamboanga del Norte, subject to RTMI's compliance to the jurisdictional and documentary requirements, after due notice and hearing to be conducted by the Board.
