**BOARD RESOLUTION NO. 096  
SERIES OF 2021**

**WHEREAS**, on 7 October 2020, Route Number 3152 “*Cubao(Mercury) – Roces Super Palengke*” with 3.4km length was opened by this office by virtue of Memorandum Circular No. 2020-058;

**WHEREAS**, the said route opening was due to the calibrated and gradual opening of public transportation in Metro Manila to serve passenger demand;

**WHEREAS**, on 18 February 2021, Hon Armida F. Castel, the Barangay Chairperson of Brgy. Kamuning Quezon City made representations with this office that the LGU sometime in 2018 implemented an Alternate One-way Route in Brgy. Kamuning to ease traffic flow. With this, instead of just one street being utilized by the PUJ operators plying the route Cubao (Mercury) - Roces Super Palengke, it became two (2), i.e K-1<sup>st</sup> Street and K-2<sup>nd</sup> Street. The Barangay LGU afterwards has been receiving complaints from residents regarding the noise and pollution that the PUJs are emitting when they pass through these streets;

**WHEREAS**, it is the desire of the Barangay LGU and residents to divert the route of the PUJs plying the abovementioned route to the adjacent streets;

**WHEREAS**, on 2 March 2021 an ocular inspection was conducted and the claim of the Barangay LGU was verified;

**NOW THEREFORE**, for and in consideration of the foregoing, the Board hereby resolves to **APPROVE** the request of re-routing of PUJs plying Roces – Cubao (Mercury) from Road - Luis Sianghio – K-5<sup>th</sup> - T.Gener – K-2<sup>nd</sup> - Judge Jimenez and Judge Jimenez – K-1<sup>st</sup> -T.Gener – K-5<sup>th</sup> - Luis Sianghio St. - Kamuning Rd., its new route will now be **Kamuning Rd. - Luis Sianghio – K-5<sup>th</sup> - T. Gener St. – Kamuning Rd. - Judge Jimenez and Vice Versa.**
