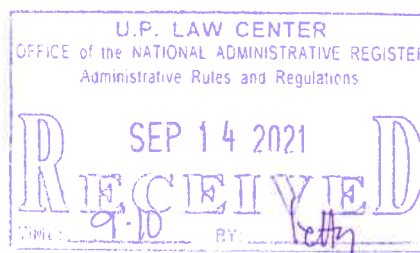
SUBJECT: AMENDMENT TO MEMORANDUM CIRCULAR NO. 2021-051 (re: AUTHORIZED MODE OF ROUTES UNDER PADRE BURGOS, QUEZON LOCAL PUBLIC TRANSPORT ROUTE PLAN)

WHEREAS, on 16 August 2021, the Board issued Memorandum Circular No. 2021-051, Re: OPENING OF APPLICATIONS FOR THE ISSUANCE OF NEW CERTIFICATE OF PUBLIC CONVENIENCE (CPC) OF PADRE BURGOS, QUEZON UNDER THE IMPLEMENTATION OF PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP);
