MEMORANDUM CIRCULAR
Number 2021- 062

SUBJECT : LIST OF PRE-QUALIFIED INTERIM SCRAPPING FACILITIES UNDER THE VEHICLE USEFUL LIFE PROGRAM (VULP) COMPONENT OF THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUVMP)

WHEREAS, on 19 June 2017, the Department of Transportation (DOTr) issued Department Order No. 2017-011 (Re: Omnibus Guidelines on the Planning and Identification of Public Road Transportation Services and Franchise Issuance) adopting the rules and procedures for the issuance of franchises for public transport routes and services;

WHEREAS, on 11 November 2020, the DOTr issued **Department Order No. 2020-021** re: *Guidelines for the Scrapping of Old Public Utility Vehicles Units (PUVs) under the Department Order 2017-011 otherwise known as the Omnibus Franchising Guidelines (OFG)*;

WHEREAS, provided in the above-mentioned Department Order No. 2020-021 are the guidelines, processes, conditions, and requirements governing the implementation and accreditation of interim scrapping facilities;

WHEREAS, relative to the implementation of the Department Order No. 2020-021, the LTFRB and Land Transportation Authority (LTO) issued a Joint Memorandum Circular (JMC) No. 001, Series of 2021, dated February 23, 2021, Re: Implementing guidelines to govern the accreditation of scrapping facilities and manner of scrapping of public utility vehicles;

WHEREAS, the DOTr – Road Transport and Infrastructure issued a Memorandum, dated March 25, 2021, endorsing to the LTFRB the list of scrapping facilities with business name registration with the Department of Trade and Industry (DTI) for validation and for issuance of a list of qualified scrapping facilities;

WHEREAS, the DOTr – Road Transport and Infrastructure issued another Memorandum, dated April 28, 2021, endorsing to the LTFRB the list of Department of Environmental and Natural Resources (DENR) registered treatment, storage and disposal facilities to be cascaded to the regional offices for reference of the scrapping facilities ;

WHEREAS, pursuant to Department Order No. 2020-021, a Memorandum was issued by the LTFRB Officer-in-Charge of the Office of the Chairman P/Col. Joel C. Pernito (retired), dated April 7, 2021, to the Regional Franchising and Regulatory Offices (RFROs) to nominate and designate Regional Secretariats within their office that will validate and inspect within their respective regions the list of facilities provided by the DTI ;

WHEREAS, on various dates, the respective RFROs conducted inspection and validation of the said scrapping facilities within their regions based on the scrapping facility requirements provided in JMC No. 001, Series of 2021 and submitted their findings to the Board pursuant to above-mentioned Memorandum;

NOW THEREFORE, for and in consideration of the foregoing, the Board **RESOLVES** and **ISSUES** the list of scrapping facilities pre-qualified to apply for accreditation of LTFRB based

on the JMC No. 001, Series of 2021 (attached herein the "Annex A" and forms an integral part of this Memorandum).

The provisions under Joint Memorandum Circular No. 2021 - 001 dated on February 23, 2021 on Implementing Guidelines to Govern Accreditation of Scrappage Facilities and Manner of Scrapping of Public Utility Vehicles, shall be deemed applicable herein"

All issuances inconsistent herewith are hereby superseded and amended accordingly.

This Memorandum Circular shall take effect immediately following its publication in at least one (1) newspaper of general circulation. Let three (3) copies hereof be filed with the UP Law Center – Office of National Administrative Registrar (ONAR).
