RESOLUTION NO. 119 Series of 2021

(Re: Accreditation of TM-11 Enterprises
as a GPS Device Provider)

WHEREAS, on 30 June 2021, the Pre-Accreditation Committee for GPS Device Providers created under Memorandum Circular No. 2015-013 issued a Resolution numbered 71 series of 2021 wherein the Committee resolved:

“NOW THEREFORE, premises considered, finding the documents submitted by TM-11 Enterprises on 5 May 2021 to be incomplete due to its failure to submit/provide the above-mentioned documentary requirements set forth under Memorandum Circular Nos. 2015-013 and 2016-016, this Committee resolves to **DIRECT** the herein applicant to **SUBMIT** to the Pre-Accreditation Committee of the same within fifteen (15) working days from receipt of this resolution.”

WHEREAS, the documentary requirements which the applicant TM-11 Enterprises needed to submit are the following:

1. List of all clients (with contact person, address and telephone/mobile number in the Transportation Industry for the last 2 years);
2. Warranty of the GPS Device, which shall not be less than one (1) year from installation (must be signed);
3. Proposed procedure for Repair and Replacement of Defective GPS Device (must be signed);
4. Company policy and procedure for resolution of complaints from the operators (must be signed);


WHEREAS, on 9 July 2021, applicant TM-11 Enterprises submitted its compliance to the above-mentioned resolution wherein an evaluation was thereafter conducted by the Committee and a recommendation was made on 13 August 2021;

WHEREAS, applicant TM-11 Enterprises has still failed to comply with the directive to submit the following requirements:

1. List of all clients (with contact person, address and telephone/mobile number in the Transportation Industry for the last 2 years);
2. Warranty of the GPS Device, which shall not be less than one (1) year from installation (must be signed);

NOW THEREFORE, premises considered, finding the application of TM-11 Enterprises to be incomplete due to its failure to submit/provide the above-mentioned documentary requirements set forth under Memorandum Circular Nos. 2015-013 and 2016-016, this Committee resolves to **DIRECT** the herein applicant to **SUBMIT** to the Pre-Accreditation Committee of the same within fifteen (15) working days from receipt of this resolution.
