BOARD RESOLUTION NO. 156
Series of 2021

WHEREAS, the Board has identified two (2) Terminals designated to cater PUVs and Passengers coming from the North, namely: North Luzon Express Terminal (NLET) and Valenzuela Gateway Complex (VGC) Terminal;

WHEREAS, it is already anticipated that during holiday season, along with the relaxation of travel restriction across the country would bring more commuters and passengers to influx at the designated terminals;

WHEREAS, the objective of the Board is to ensure that there are sufficient public transportation services in the identified major terminals necessary to augment the demand of the commuting public;

WHEREAS, based on the monitoring report of the Franchise Planning and Monitoring Division (FPMD), it recommended to temporarily modify the route structure of some PUVs operating to and from Bulacan area passing through the identified terminals in order to maintain the availability of PUVs, for the convenient transfers of passengers in terminals;

NOW THEREFORE, for and in consideration of the foregoing, the Board resolves as it hereby resolved to **TEMPORARILY MODIFY** the routes going to and from Bulacan area, more particularly described as follows:

A. For Public Utility Jeepney (PUJ) route:

1. Monumento – Sta. Maria via Expressway, shall pick and drop passengers at **NLET and VGC**.

The fare shall be based on the existing fare guide for PUJs.

B. For Public Utility Bus (PUB) routes:

1. Route No. 3 is modified from Monumento – VGC via NLEX to **Monumento – NLET via VGC, NLEX**.

The existing fare guide for City Buses shall apply. However, for passengers originating or terminating at NLET, special fare shall apply, to wit:

	Regular	Student/Elderly/Disabled
NLET – Monumento and vice versa	33.25	26.50

2. Route No. 32 is modified from North EDSA – VGC to **North EDSA – NLET via VGC, NLEX, Mindanao Exit**.

The existing fare guide for City Buses shall apply. However, for passengers originating or terminating at NLET, special fare shall apply, to wit:

	Regular	Student/ Elderly/Disabled
NLET – North EDSA and vice versa	36.75	29.50

3. Route No. 22: **Angat, Bulacan – Monumento**, shall pick and drop passengers at **NLET**.

The existing fare guide for City Buses shall apply. However, for passengers originating or terminating at NLET, special fare shall apply, to wit:

	Regular	Student/ Elderly/Disabled
NLET – Monumento and vice versa	33.25	26.50

C. For P2P route

1. Bocaue/Sta. Maria – North EDSA, shall have a special stop to pick and drop passengers at **NLET**.

The fare shall be One Hundred Seventy Pesos (Php170.00).

PUVs covered under this Resolution shall continue to operate on the above routes until later on modified or recalled by the Board through a subsequent issuance.

Further, PUV operators, drivers, conductors and passengers are reminded to strictly comply relevant issuances on the observance of health protocols inside PUVs.
