RESOLUTION NO. 160 Series of 2021

(Re: Application of Pasay Cavite Transport Cooperative for the Issuance of New CPC for the route: BRGY. PALIPARAN, DASMARIÑAS, CAVITE TO PITX VIA MOLINO under Memorandum Circular No. 2018-027)

WHEREAS, on 29 October 2019, Pasay Cavite Transport Cooperative filed its letter of intent and qualification documents to apply for the route BRGY. PALIPARAN, DASMARIÑAS, CAVITE TO PITX VIA MOLINO under Memorandum Circular No. 2018-027 with the use of fifty (50) Class 3 UV units and the selection proceedings was thereafter conducted on 19 February 2020;

WHEREAS, the Committee found that Pasay Cavite Transport Cooperative has submitted only photocopies of its Amended Articles of Cooperation and By-Laws;

WHEREAS, applicant Pasay Cavite Transport Cooperative submitted duly signed and notarized undertaking that 25% of the number of required units will be delivered within three (3) months, 50% within six (6) months, 100% within nine (9) months dated 28 October 2019 with attached supporting Certificate of Delivery from Motormall NCR, Inc. (Hino Pasig) dated 28 October 2019 signed by its Sales Manager - Andrew A. Solon;

WHEREAS, the Committee found that Pasay Cavite Transport Cooperative failed to include/submit in its qualification documents the following documentary requirements set forth in Memorandum Circular No. 2019-013:

1. Organized vehicle dispatch procedures for its Fleet Management System;
2. Copies of Letter of Support from property owners/managers regarding access to, or use of, each off-street loading and unloading area in BRGY. PALIPARAN, DASMARIÑAS, CAVITE endpoint;

WHEREAS, President Rodrigo Roa Duterte signed Proclamation No. 922 entitled "Declaring a State of Public Health Emergency Throughout the Philippines" on 8 March 2020 relative to the alert of World Health Organization in December 2019 on the threat of COVID-19;

WHEREAS, the Selection Process has been conducted for the new/developmental routes under the Memorandum Circular No. 2018-027 before the declaration of community quarantine in the Philippines on the onset of COVID-19;

WHEREAS, on 24 November 2021, the Board has issued its Resolution numbered 137 S. 2021 to proceed with all pending processes involving the Selection Process for the herein route;

NOW THEREFORE, premises considered, this Committee resolves to **DIRECT** the applicant Pasay Cavite Transport Cooperative to **SUBMIT** within fifteen working (15) days from receipt of this resolution the (1) Original or Certified True Copies of Pasay Cavite Transport Cooperative's Amended Articles of Cooperation and By-Laws, (2) Organized vehicle dispatch procedures for its Fleet Management System, and (3) copy of Letter of Support from property owners/managers regarding access to, or use of, each off-street loading and unloading area in Brgy. Paliparan, Dasmariñas, Cavite endpoint. Failure to comply within the period specified herein shall cause the dismissal of the application.
