BOARD RESOLUTION NO. 034 Series of 2022
 (re: Application for Accreditation of JOYRIDE E-COMMERCE
 TECHNOLOGIES CORP. as Transportation Network Company)

WHEREAS, on _____, the Pre-Accreditation Committee for the applications for accreditation of Transport Network Company has issued Resolution No. 033, series of 2022, stated thus:

“NOW THEREFORE, for and in consideration of the foregoing, the PAC hereby recommends to the Board to **GRANT** herein Applicant, JOYRIDE E-COMMERCE TECHNOLOGIES CORP. its Certificate of Accreditation as a Transport Network Company (TNC) pursuant to the provisions set forth under Memorandum Circular No. 2021-066.

Furthermore, the grantee shall be ready and available in the market to accept Transport Network Vehicle Services issued with the necessary authority to operate i.e., Provisional Authority and/or Certificate of Public Convenience, relative to its immediate and significant operations of the grantee as a TNC, within thirty (30) days from receipt of its Certificate of Accreditation.”

NOW THEREFORE, in view of the recommendation of the Pre-Accreditation Committee, the Board hereby resolves to **GRANT** accreditation to JOYRIDE E-COMMERCE TECHNOLOGIES CORP. with validity period of two (2) years from issuance of the Certificate of Accreditation, which may be renewed, cancelled, or suspended, subject to the compliance of the requirements in the Memorandum Circular No. 2021-066 and existing policies, rules, regulations and orders of the Board.

The grantee shall be ready and available in the market to accept Transport Network Vehicle Services issued with the necessary authority to operate i.e., Provisional Authority and/or Certificate of Public Convenience, relative to its immediate and significant operations of the grantee as a TNC, within thirty (30) days from receipt of its Certificate of Accreditation.

Further, as an accredited TNC, the same shall subject to a periodic performance review by the Pre-Accreditation Committee every six (6) months from the date of accreditation, in accordance with the Board Resolution No. 087 S. 2021 and the aforementioned MC.


