BOARD RESOLUTION NO. 038
Series of 2022

WHEREAS, President Rodrigo Roa Duterte signed Proclamation No. 922 entitled "Declaring a State of Public Health Emergency Throughout the Philippines" on 8 March 2020 in view of the reported COVID-19 cases in the country, which was later on extended until 12 September 2022 through Presidential Proclamation No. 1218;

WHEREAS, since the start of the COVID-19 pandemic, the Inter-Agency Task Force for the management of Emerging Infectious Diseases (IATF-EID) has issued guidelines for the different quarantine classification in the country, namely: Enhanced Community Quarantine (ECQ), Modified Enhanced Community Quarantine (MECQ), General Community Quarantine (GCQ), and Modified General Community Quarantine (MGCQ);

WHEREAS, in the midst of COVID-19 pandemic, numerous Memorandum Circulars (MCs) and Board Resolutions (BRs) were issued, anchored on the guidelines prescribed under the different quarantine classification;

WHEREAS, on 13 September 2021, the IATF has adopted and published the Guidelines for the Pilot Implementation of Alert Level System in the National Capital Region, as the new Community Quarantine Classifications for dealing with COVID-19 covering entire cities, municipalities and/or regions;

WHEREAS, subsequently, on 18 November 2021, the IATF issued Guidelines on the Nationwide Implementation of Alert Level System for COVID-19 Response, namely: Alert Level 1, Alert Level 2, Alert Level 3, Alert Level 4, and Alert Level 5;

WHEREAS, in order to clarify the effect of the change in the community quarantine classification particularly with respect to the issued MCs and BRs, the Board deems it necessary to issue this Resolution;

NOW THEREFORE, for and in consideration of the foregoing, the Board, in adopting the new quarantine classification, hereby resolves that MCs and BRs previously issued prior to the change in the Community Quarantine Classification shall remain in full force and effect, unless the same is subsequently clarified or modified through the issuance of another MC or BR.


