BOARD RESOLUTION NO. 086
Series of 2022

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) is a registered owner of a lot located at Magalang, Pampanga purposely used by the office as its impounding area for impounded vehicles;

WHEREAS, the said impounding area is being manned by Security Guards of Commander Security Services, Inc. contracted by the LTFRB to secure the impounded vehicles;

WHEREAS, on 20 September 2019, the security guards of LTFRB impounding area caught two (2) individuals stealing four (4) Toyota Car Emblems inside the impounding area, hence, a case was filed before the Office of the Provincial Prosecutor, San Fernando, Pampanga against the two (2) individuals, namely, Edgardo B. Cabute and Alvin S. Cortez, docketed under Case No. III-12-INQ-191-03571;

WHEREAS, in order to facilitate the representation of the Board during the hearings, and for the proper delegation of the corresponding authority, it is deemed necessary to issue this Resolution;


NOW THEREFORE, for and in consideration of the foregoing, the Board hereby grants upon **Mr. Reyson R. Torres**, a permanent employee of LTFRB occupying the position of Technical Development Officer I, the following authority in the prosecution of the said case, to wit:

1. To stand as a complainant, for and on behalf of the LTFRB, and to appear, testify and represent the LTFRB in all proceedings and hearings for the prosecution of the case;
2. To file and sign the appropriate pleadings, motions, verifications, including a motion for reconsideration, and a petition for review;
3. To appear in the preliminary conferences, pre-trials, mediations, and other proceedings in the said criminal case;
4. To consider simplification of issues and the possibility of entering into stipulation of facts, and such other purposes of Pre-trials as are specified by the Rules of Court of the Philippines; and,
5. To enter into settlement or compromise agreements regarding the civil aspect of said criminal case, subject to prior approval from the Board.


Further, also authorizing either **Atty. Theresa B. Magtoto**, Chief Technical Development Officer of LTFRB RFRO III, or **Atty. Jennifer Ann G.**

Rodriguez, Attorney IV of LTFRB RFRO III, to provide legal assistance to Mr. Reyson R. Torres/LTFRB in the aforementioned case.
