**RESOLUTION NO. 089 Series of 2022**

(Re: Application of Pasay Cavite Transport Cooperative for the Issuance of New CPC for the route: BRGY. PALIPARAN, DASMARIÑAS, CAVITE TO PITX VIA MOLINO under Memorandum Circular No. 2018-027)

**WHEREAS**, 29 December 2021, the Qualification Committee issued its Resolution No. 160 S. 2021 wherein the committee resolved to:

**"NOW THEREFORE**, premises considered, this Committee resolves to **DIRECT** the applicant Pasay Cavite Transport Cooperative to **SUBMIT** within fifteen working (15) days from receipt of this resolution the (1) Original or Certified True Copies of Pasay Cavite Transport Cooperative's Amended Articles of Cooperation and By-Laws, (2) Organized vehicle dispatch procedures for its Fleet Management System, and (3) copy of Letter of Support from property owners/managers regarding access to, or use of, each off-street loading and unloading area in Brgy. Paliparan, Dasmariñas, Cavite endpoint. Failure to comply within the period specified herein shall cause the dismissal of the application."

**WHEREAS**, on 4 February 2022, herein applicant submitted its compliance with the abovementioned resolution;

**WHEREAS**, after careful and thorough evaluation of the above application and its supporting documents, the Qualification Committee finds that the herein applicant is complete and compliant with Memorandum Circular No. 2019-013;

**NOW THEREFORE**, premises considered, this Committee resolves to recommend to the Board to **AWARD** and **AUTHORIZE** the applied fifty (50) Class 3 UV units for the route Brgy. Paliparan, Dasmariñas, Cavite to PITX via Molino under Memorandum Circular No. 2018-027 in favor of Pasay Cavite Transport Cooperative.


