**RESOLUTION NO. 094 Series of 2022**

(re: Application for Accreditation of PURE RIDE CORPORATION  
as Transportation Network Company)

**WHEREAS**, relative to the issued Memorandum Circular No. 2021-066, lifting the moratorium in the acceptance of Application for Accreditation of Transport Network Company (TNC), herein Applicant, Pure Ride Corporation (Pure Ride for brevity) submitted its Application to the Pre-Accreditation Committee (PAC) on 20 January 2022;

**WHEREAS**, on 10 February 2022, the members of the PAC convened in a meeting, there having a quorum, they proceeded with the evaluation and deliberation of the Application submitted by Pure Ride;

**WHEREAS**, after careful examination of the documents submitted, the PAC found that Pure Ride failed to submit the following documentary requirements, as well as the other significant remarks found on the submitted documents, to wit:

1. The primary purpose of the Applicant submitted before the committee is *“xxx to engage in, conduct and carry on the business of Car Rentals except financial leasing.”*. Hence, its failure to submit the necessary Certificate of Registration of Incorporation issued by the Securities and Exchange Commission and Articles of Incorporation and By-Laws with primary purpose as “TNC or Transportation”.  
(emphasis ours.)
2. Failure to submit its Secretary’s Certificate of the Board/Partnership Resolution authorizing the representative to sign the Application for Accreditation for and in behalf of the corporation;
3. Failure to submit its Secretary’s Certificate of Incumbent Corporate/Partnership Officers and List of Directors/Partners;
4. Submitted Business Permit duly issued by the local government where the applicant’s principal place of business is located appears to have:
  - a. been issued dated 22 January 2021 (No Renewal),
  - b. has two (2) employees only,
  - c. and no relation to operations as a TNC (Car Rental).
5. Submitted Certificate of Registration duly issued by the Bureau of Internal Revenue dated 7 October 2021 indicates that the corporation’s Line of Business is a Car Rental which categorized as Primary, not as a TNC or Transportation;
6. Applicant has submitted the LTFRB’s process on the application for issuance of CPC as to the required Process of Accrediting/ Affiliating TNVS vehicles, hence, failure on the submission of the latter;
7. Failure to submit its Process of Accrediting/ Affiliating TNVS/Taxi Drivers due to incomplete process and setting of internal guidelines;
8. Failure to include in its submission of Terms of Service for Passengers its Liability as required under Item No. V of LTFRB Memorandum Circular No. 2021-066;
9. Failure to submit its Terms of Service for TNVS Operators;
10. Failure to submit its Proposal Fare Rates and/or Service Charges;

11. Failure to submit its Undertaking to comply with the Terms and Conditions for a Certificate of TNC Accreditation;
12. Incomplete Complaint Mechanism in terms of filing and process flow on the completion and full resolution of complaints;

**WHEREAS**, taking into consideration the role of TNCs in the operation of Transport Network Vehicle Services in the country, Applicants must fully comply and satisfy all the requirements of the MC No. 2021-066, to warrant the issuance of a Certificate of Accreditation;

**NOW THEREFORE**, for and in consideration of the foregoing, the PAC hereby recommends to the Board to **DENY** herein Applicant, PURE RIDE CORPORATION its Certificate of Accreditation as a Transport Network Company (TNC) for its failure to comply with the provisions set forth under Memorandum Circular No. 2021-066. This is however without prejudice on the applicant's part to re-apply or submit its application for accreditation.
