**BOARD RESOLUTION NO. 097**

**WHEREAS**, the Land Transportation Franchising and Regulatory Board (LTFRB), as an agency under the administrative supervision and control of the DOTr, is mandated to promulgate, administer, enforce and monitor compliance of policies, laws, and regulations of public land transportation services;

**WHEREAS**, one of the Regional Offices of the LTFRB in Northern Luzon is the LTFRB Regional Franchising and Regulatory Office- Cordillera Administrative Region (RFRO-CAR), which is currently occupying an office at the Department of Transportation- Cordillera Administrative Region (DOTr-CAR) building;

**WHEREAS**, part of the approved budget under Republic Act 11639 Otherwise Known as the General Appropriations Act (GAA) 2022 is the Maintenance and Other Operating Expenses and Capital Outlay allocated to LTFRB RFRO-CAR, the disbursements of which shall be done at the LTFRB Central Office;

**WHEREAS**, in order for the LTFRB RFRO-CAR to carry-out its mandate, a more spacious and suitable office is deemed necessary to properly serve all its stakeholders;

**WHEREAS**, the Baguio Benguet Community Credit Cooperative (BBCCC) has offered to LTFRB RFRO-CAR its building located at No. 56 Cooperative Street Assumption Road, Baguio City for lease;

**WHEREAS**, to legally bind the parties, and facilitate the execution of Lease Agreement and other legal documents, it is deemed proper to designate a duly authorized representative of the LTFRB to sign and process said documents;

**NOW THEREFORE**, for and in consideration of the foregoing, the Board resolves as it is hereby resolved to **AUTHORIZE** the Officer-in-Charge, Regional Director of LTFRB RFRO-CAR, **ENGR. LALAIN E. SOBREMONT E** full authority to sign, execute, and process all documentary requirements relative to the lease of the building and the application and installation of necessary utilities needed for the fully functional office building.
